SCHOLARSHIP RULES

The Huffman Young Farmers are proud to support our youth for their hard work and dedication. We realize that our students would not be successful without the help, support, and guidance from their families, sponsors, teachers and community. As such, the Huffman Young Farmer Scholarship(s) will be presented annually as funds are available and in amounts determined by the Scholarship Selection Committee & Executive Board. Below are the rules pertaining to the Young Farmers Scholarship.

1. Any active member of the Huffman FFA who is a current year graduating student and who meets the rules set forth below is eligible to apply for the Huffman Young Farmers Scholarship.
2. Applicants must have completed or be enrolled in at least four semesters of High School Agricultural Courses (Courses taken at a High School Campus) that were obtained over a minimum of 2 separate school years.
3. Applicants must submit a current and completed Huffman Young Farmers Scholarship application. The application, where required, must be signed by the designated individuals (i.e. student, parent, Ag advisor, etc.). Incomplete applications will be returned for corrections.
4. Applicants must submit an essay that is 1 page long, typed & single spaced answering the following: Drawing on your experiences & knowledge gained while in FFA, list three ways you can teach others you meet about FFA, agriculture in America & how everyone benefits.
5. All scholarship applicants should be in Official FFA Dress at the scholarship interview.
6. It is mandatory that scholarship recipients attend an accredited college, accredited university or trade school in the fall or spring semester immediately following selection in order to receive the funds. If the student does not attend in the fall or spring semester following selection, the funds may be forfeited unless as indicated in item #8 below.
7. Only with special permission from Huffman Young Farmers may the use of the scholarship be deferred one year. The scholarship recipient must make a request in writing, explain the reason for the requested deferment, and submit this request to the Huffman Young Farmers and FFA Advisor. Huffman Young Farmers will notify the recipient of their decision.
8. Scholarship funds will be paid in full directly to the accredited college, accredited university, or trade school selected by the student upon enrollment and acceptance. In no instance will funds be paid directly to the student or family.
9. If any information is found to be intentionally falsified the scholarship application may be disqualified.
10. All scholarship applications will become the property of the Huffman Young Farmers and all decisions made by the committee are final. Final interpretation of rules is at the sole discretion of the Scholarship Selection Committee and Executive Board.
